1. All participants must submit artwork by the deadline, **April 30, 2020**.
2. We are interested in work that captures the spirit of the Asato Family Shop and or our “Local Kine” Sherbert!
3. Submissions will be judged digitally. Submissions should be emailed to keikiartdept@gmail.com. Please scan artwork or take a high quality photo of artwork and send to email above.
4. Keiki Art Dept. / Asato Family Shop will choose 10 finalists. Winners will be contacted via email.
5. Original artwork will be dropped off or be mailed Asato Family Shop on a to be determined date. Winning artwork will be displayed at Asato Family Shop, Customers/community will cast their vote via instagram and in-shop voting for their favorite artwork.
6. Chosen pieces must arrive at Asato Family Shop at a to be determined date (after the Coronavirus has passed)
7. Artwork must be 8.5” x 11” (standard printer paper size) Artwork doesn’t have to be on standard paper but artwork must be the 8.5” x 11” in dimension.
8. Contestants are limited to five (5) entries each. Entries may be in a medium of the artist's choice.
9. Photography entries will be accepted but need to fit the 8.5” x 11” dimensions.
10. Winning entries are not to be framed.
11. Artist eligible for entry must 12 years old or younger
